## Terms and Conditions

### 1. Scope

These Terms and Conditions apply to all deliveries from LTB Limited to the Buyer. Deviating conditions of the Buyer are not accepted by LTB limited, unless LTB Limited has explicitly agreed in writing.

### 2. Offer and Contract

The presentation of products in our online shop is not a legally binding offer, but an invitation to order. All offers are valid "while stocks last", if not stated otherwise with the products.

By clicking "order" in the last step of the ordering process, the customer creates a binding order. The sales contract is concluded when we accept the order with an order confirmation via e-mail after receiving the order.

The full text of the contract is not stored by us. Before submitting the order, the contract data can be printed by using the print function of the browser or saved electronically.

### 3. Delivery

The delivery time is 28 business days from the date of the paid order. We strive to meet delivery deadlines. In case of delivery delays due to circumstances that were not known to us when placing the order and were not caused by us, delivery periods will be extended by a reasonable length.

The time limit begins after the receipt of this instruction in text form (eg letter, fax, e-mail), and not before receipt of the goods by the recipient.
